Further to the Appendix 3B announced on 11 November 2016 for the issue of 65,500,000 fully paid ordinary shares that have been issued at \$0.0018 **Victory Mines Limited** (ASX: VIC) ('Company') provides the following information required under ASX Listing Rule 3.10.5A.

### Details of issue under 10% Placement Facility (LR 7.1A)

a) The dilutive effect of the issue on existing shareholders is as follows:
